



# VEHICLE USE AGREEMENT

## Program to Program

**Section 1. Vehicles and Rent.** Owner agrees to lease to User, and User agrees to hire from Owner, the motor vehicles specified below.

**Section 2. Rental Fee.** User shall pay Owner an ongoing rental fee of \$\_\_\_\_\_ per mile used. A log shall be kept by the User of all mileage and submitted to the Owner monthly. User shall initiate a Fund to Fund transfer each month for the rent due.

**Section 4. State, County, City Registration, Licensing, and Taxes.** Owner shall accomplish and pay for the titling, registration, and licensing of the Vehicle. Owner shall make such title, license, and/or certificate of registration available for User's reasonable inspection.

**Section 5. Maintenance and Fuel Costs.** Owner shall keep and maintain the Vehicle in good operating condition for the Permitted Use. Owner shall be responsible for all maintenance and repairs to safely operate the Vehicle for the Permitted Use. Owner agrees to pay the cost of all fuel required for the Permitted Use.

**Section 6. User's Damage to the Vehicle.** The User shall return the Vehicle in as good condition as when received by User, ordinary wear and tear and damage or defects, and natural depreciation, excepted. If during the term or upon the expiration or termination of the Agreement, the Vehicle is returned in an unsatisfactory condition after inspection by the Owner, excepting ordinary wear and tear and natural depreciation, the User shall pay the Owner's cost of cleaning, repairing, or replacing any damage to the

Vehicle directly related to the Permitted Use and caused: (a) by negligent or reckless treatment in the care and operation of the Vehicle; (b) by traffic accidents; or (c) by towing, pushing, plowing and/or illegal uses, none of which shall be considered ordinary wear and tear or natural depreciation.
